Minutes of a meeting held in the Small Hall, St. Edith Hall, Kemsing, on Wednesday, 21st January 2015 at 7.30 p.m.

Dr. P. Walker **APOLOGIES:**

Mrs. Cole welcomed everyone to the meeting and invited Kemsing Primary School to provide an update on the swimming pool project. The project is now almost complete: the structure had been erected, filtration system was in place and it was hoped that the installation of the cubicles would be completed soon. Arrangements would be made to appoint qualified instructors/life guards before the swimming pool could be used. An official Open Day would take place in April 2015. Mrs. Cole asked if the swimming pool would be opened to the general public. The Chair of the PTA confirmed that Kemsing Primary School had anticipated making the facilities available to the wider community of Kemsing in due course. The Parish Council was presented with a gift made up from letters of appreciation from the pupils and Mrs. Cole thanked the PTA and Kemsing Primary School for all their hard work with this project.

QUESTIONS FROM THE PUBLIC & PRESS 1.

There were no questions from the public or press.

2. **MINUTES**

Mrs. Cole proposed:

The Parish Council RESOLVED that under the Public Bodies (Admission to meetings) Act 1960, the public and representatives of the press were to be excluded from the meeting during the consideration of items 3(a), 3(c) and 4(c) as publicity would be prejudicial to the public interest because of the confidential nature of the business to be transacted.

(d) Church Lane junction with Heaverham Road, Kemsing (Minute 5 KPC/10/2014)

Kent Highways and Transportation's had concluded that the matter would not be progressed. Road safety improvements were being prioritised to the sites most in need of changes and these schemes should all pass the set criteria.

Mr. Dawes proposed and Mrs. Cole seconded:

Mr. Dawes proposed and Mr. Andrews seconded:

"That the Parish Council accepts the minutes of the meeting held on 12^{th} January 2015, Ref No P/01/2015, subject to the following amendment:-

Page 2, paragraph 7, 7th line should read: 'could be reduced by 1 metre but no more, otherwise it would impinge on the floor space, making'" CARRIED 11 in favour, 1 abstention {Mrs. Robarts}

(b) Recreation Grounds Committee

Mrs. Dickinson proposed and Mrs. Wedderburn seconded:

"That the Parish Council accepts the minutes of the meeting held on 26th November 2014, Reference RG/05/2014, including the following recommendation:

Item 2(m) - "That the Committee recommends to the Parish Council that the installation of the memorial seat should be paid for from the Parish Council's General Contingency Fund." CARRIED unanimously

There was no report form the Chairman.

(e) Reports from Councillors

Proposed footbridge installation at Otford Railway Station: Mr. Buttifant had attended an open session event at Otford on 14th January 2015, regarding Network Rail's proposal to replace the existing foot crossing at Otford Railway Station with a footbridge.

Mr. Buttifant would seek the view of Otford Parish Council on this proposal and would report back at a future Parish Council meeting.

(f) Report from District Councillors

There were no reports from District Councillors.

5. KEMSING PAVILION TRUST – REQUEST TO CREATE ADDITIONAL FOOTPATH FROM THE TENNIS COURT CAR PARK TO THE SIR MARK COLLET PAVILION

Members considered a letter dated 13th November 2014 from the Kemsing Pavilion Trustees, asking the Parish Council's permission to create a footpath on the section of land between the tennis court fence and the hedgerow. This was raised as a result of a recent risk assessment during which a safety concern presented by the narrow footway from the tennis court car park to the Pavilion (alongside Heaverham Road.

Although the Trust offered to fund the project, it required permission from the Parish Council and the Kemsing Lawn Tennis Club.

After the debate, Mrs. Cole proposed:

"That the Parish Council writes back to the Pavilion Trustees to enquire whether they had sought the view of the Kemsing Lawn Tennis Club."

CARRIED unanimously

Mr. Croughton proposed and Mrs. Cole seconded:
