(c) Reports from Councillors

- (i) Grass verges along Childsbridge Lane Mrs. Wedderburn asked if the Parish Council would consider requesting Kent County Council (KCC) Highways and Transportation to improve the poor condition of the grass verges, particularly the stretch of road from the cross roads to Pilgrims Way junction, on both the West and East sides of Childsbridge Lane. The grass verges were severely damaged and in some cases, destroyed, as a result of vehicles being parked on them, in particular vehicles relating to building work in the area, and KCC owned vehicles during the footpath restoration work recently carried out.
 - > RESOLVED: The Clerk to report the problem to KCC. In the event that KCC would not be prepared to carry out necessary remedial work, the matter would be referred to County Councillor Mr. Nick Chard.
