Minutes of the Annual General Meeting of the Council held in the Small Hall, St. Edith Hall, Kemsing, on Wednesday, 21 May 2014 at 7.30 p.m.

1. ELECTION OF CHAIRMAN

Mr. Croughton proposed and Dr. Walker seconded:

"That Mrs. Cole be appointed as Chairman for the ensuing year."

CARRIED unanimously

2. **ELECTION OF VICE-CHAIRMAN**

Mrs. Cole proposed:

"That Mr. Croughton be appointed as Vice-Chairman for the ensuing year."

CARRIED unanimously

3. MEMBERSHIP OF COUNCIL COMMITTEES

The appointment of Members to Council Committees for 2014/2015 was approved and is appended to the Minutes.

- (b) Mr. Buttifant was appointed as the Highways Officer for the ensuing year.

6. CALENDAR OF COUNCIL AND COMMITTEE MEETINGS

The calendar of meetings for the ensuing year was approved.

7. MINUTES

Mrs. Cole proposed:

"That the minutes of the meeting held on 16 April 2014, Ref KPC/04/2014 be approved." CARRIED unanimously

8. MATTERS ARISING FROM THE LAST MINUTES

(a) Sewer at School Alley (Footpath SR35) (Minute 2(a) KPC/04/2014)

Thames Water had attended to the site on 16th April and the blockage had been cleared. Further sewer checks had revealed no problems and the case was closed. The Clerk thanked Thames Water for clearing the blockage but reminded them that the Parish Council had asked for a site visit, which did not happen. Thames Water had promised to contact the Clerk week beginning 5th May to arrange a visit to explain the problems with the sewerage system at this location. To date no reply from Thames Water had been received. The Clerk contacted them again and they proposed Tuesday, 27th May 2014 to conduct a site visit.

(b) Proposed changes in the bus time table (431/432) service for Kemsing (Minute 2(b) KPC/04/2014)
Mr. Croughton and the Clerk met with the owner of Go Coach Limited on Wednesday, 30th April 2014 to explore options available for introducing one or two journeys on Saturday afternoons after 3 p.m. Mr. Croughton reported on this discussion and notes of the Bus Services Working Group meeting which took place on Wednesday, 14th May 2014, were circulated prior to the meeting and would be appended to the minutes.

Go Coach Limited confirmed their interest to provide 3 journeys on a Saturday. County Councillor Mr. N. Chard expressed his full support for this venture, and pledged £1,000 from his Members' Fund towards it, subject to the agreement of both Seal and Kemsing Parish Councils to match this. Seal Parish Council has yet to consider this proposal and would do so at its meeting scheduled for 12 June.

Miss Stack also supported this scheme and offered to apply for a grant from the Sevenoaks Big Community Fund.

It was suggested that this scheme be experimental for a trial period of 6 months, during which time the usage would be monitored in order to conduct an assessment to establish the feasibility of extending the scheme in the longer term. It was recommended that Sevenoaks Town Council be asked to contribute as the proposed three services would benefit their residents also. This would be explored if the scheme proves to be successful and the Parish Council considered it to be extended in the long term.

Mr. Croughton proposed and Dr. Walker seconded:

"That the Parish Council supports a six month trial of providing three late afternoon Saturday bus journeys from Sevenoaks to Kemsing, provided by the local Sevenoaks operator Go-Coach, in replacement of a similar facility withdrawn by Arriva, with a contribution from the Parish Council of £1,000, paid in accordance with Section 137 of the Local Government Act 1972, to be extracted from the Parish Council's General Contingency Fund."

CARRIED by a majority vote

(c) CCTV (Minute 2(c) KPC/04/2014

A report would be given at the next Parish Council meeting.

(d) Number of Parish Councillors for Kemsing (Minute 4(c) KPC/04/2014)

Councillors noted the Clerk's report which detailed the legal requirements relating to the number of Parish Councillors and Council sizes. Included in the report was information relating to the specific procedure to reduce the number of Councillors.

Mr. Bennett proposed and Mr. Andrews seconded:

"That the Parish Council does not reduce the current number of Councillors." CARRIED by a majority vote

9. QUESTIONS FROM THE PUBLIC & PRESS

There were no questions from the Public or Press.

10. COMMITTEE AND OFFICER REPORTS

(a) Planning Committee

Mr. Dawes proposed and Mr. Croughton seconded:

"That the Parish Council notes the minutes of the meeting held on 14 April 2014, Ref No P/07/2014."

CARRIED unanimously

Mr. Dawes proposed and Mr. Croughton seconded:

"That the Parish Council notes the minutes of the meeting held on 28 April 2014, Ref No P/08/2014."

(b) Report from Chairman

Play Place – The Youth Club organisers were investigating possibilities to acquire an alternative venue following the demise of the Church Hall. They were currently doing detached work with the young people on the Common Field Recreation Ground, which was not ideal. The Bell Public House had offered to make available the 'Garden Room' for the Youth Club on Monday evenings between 7 p.m. and 9 p.m. This offer was being considered by the Youth Club. Dr. Walker said that the club had thrived before the Church Hall was destroyed and commended the young people for their good behaviour and the services provided by Play Place.

(c) Reports from Councillors

There were no reports received from Councillors.

(d) Reports from District Councillors

Speed Watch – Councillor Stack and PSCO Harwood believed that a Speed Watch would be useful, particularly at Noah's Ark. They asked the Parish Council's support for the introduction of a Speed Watch Scheme in Kemsing.

Councillor Stack reminded Councillors that she and PCSO Harwood had been lobbied by the Noah's Ark Residents' Association at the Annual Parish Meeting, with their concerns regarding inappropriate speeding for the road conditions in Noah's Ark. Motorists should be made aware of the risks to other road users, for example dog walkers, pedestrians, cyclists and mums with pushchairs who all use this road. In consultation with PCSO Harwood, Miss Stack obtained the relevant information regarding the process of setting up a Speed Watch group.

Sevenoaks District Council provides all the necessary training free of charge and subsidises the equipment which is made available on loan to Parishes. Offord Parish Council, who purchased the equipment, had also indicated to Miss Stack that they would be willing to make their equipment available to Kemsing Parish Council on loan.

Miss Stack had confirmation from 4 members of the Noah's Ark Residents' Association who have expressed their interest to be part of a Speed Watch group for Kemsing. Mrs. Dickinson offered to join the Group.

Mrs. Cole proposed:

"That the Parish Council supports the establishment of a Speed Watch Group for Kemsing, led by Miss Stack, supported by PCSO Harwood." CARRIED unanimously

11. BUSINESS REQUIRED BY STATUTE

(a) Independent Internal Auditors' Report for the Year ended 31st March 2014

Members noted the Internal Auditors' Report, and in particular, a recommendation relating to the Annual meeting of the Common Field Trust. Two years ago, the Parish Council resolved to include the financial matters pertaining to the Trust on its own Annual General Meeting agenda. Advice in the report was "that the Parish Council reverts to its previous administration of the Common Field Recreation Ground Trust in order to comply with the Charity Commission's guidance and charity law". This would enable the recording of the Trust's affairs separately to the Parish Council's documents.

Mrs. Dickinson proposed and Mrs. Cole seconded:

"That the Parish Council accepts the Internal Auditor's recommendation and removes the Trust's business from the Parish Council's agenda and revert back to the previous administration of the Trust, all papers to be filed separately from the Parish Council's documents."

CARRIED unanimously

The Parish Council recorded its praise to the Clerk for the conduct of the accounts.

(b) Statement of Accounts for the Year ended 31st March 2014

Mr. Eaton proposed and Dr. Walker seconded:

"That the Parish Council approves the Statement of the accounts for the year ending 31 March 2014, as circulated."

CARRIED unanimously

(c) Annual Return for Audit Commission – Annual Governance Statement 2013/14

Mrs. Cole proposed:

"That the Parish Council approve Questions 1 to 9 of the Governance Statement, as circulated." CARRIED unanimously

(d) Notice of Appointment of date for the Exercise of Electors' rights for viewing the accounts for the year ended 31st March 2014

The notices have been displayed on the Parish Council's notice boards in accordance with the Audit Commission Act 1998, Sections 15 and 16 and The Accounts and Audit (England) Regulations 2011 (SI 2011 NO 817).

(e) <u>Appointment of Internal Auditor for the ensuing financial Year ending 31st March 2015</u> Mrs. Cole proposed:

"That the Parish Council appoints Mrs. Banister as Internal Auditor for the next Financial Year, i.e. 2014/15."

(f) Review of charge for the provision of Council and Committee Agenda & Minutes

Mr. Croughton proposed:

"That there is no increase in the current costs, i.e. £15.00 per annum for posted and £3.00 per annum collected."

12. DONATIONS & SUBSCRIPTIONS

(a) Girlguiding in Kemsing

The Rainbow, Brownie and the combined Guide/Senior Section Groups all used the St. Mary's Church Hall. The groups all lost their equipment which was stored in the Church Hall during the recent fire. The 1st Kemsing Brownies & District Commissioner Girlguiding Kemsing & Otford asked the Parish Council for financial assistance towards the cost of replacing some of the items lost in the fire.

Mr. Eaton proposed and Dr. Walker seconded:

"That the Parish Council, as a good will gesture, makes a donation of £140 towards the cost of one flag for the Kemsing Brownies."
